A CHANGE AT THE HELM

After twenty-five years of service as the Executive Director of the FISA, Mr. Fred Herfst has announced his retirement, effective in the summer of 2011. To prepare for a smooth transition to new leadership, the FISA Board has chosen his successor, who will join the FISA staff on Oct.1, 2010.

The FISA Board and Mr. Herfst heartily welcome Dr. Peter Froese to the position of Associate Executive Director and look forward to working with him as the FISA structures its future endeavors. He is eminently qualified for the work by bringing to the position exceptional educational credentials and a wealth of educational experience. He wrote his dissertation on the FISA. He has served as a teacher and as principal in public schools and understands public education; he has served as principal and superintendent of Mennonite Educational Institute and chaired Ministry of Education External Evaluation Teams visiting independent schools in BC, and also off-shore schools in China, thereby gaining an in-depth view of independent schools. He has served on the Board of the FISA, and has been a council member of the BC College of Teachers.

BYLAW AMENDMENTS

The FISA will be amending its bylaws, and as a legal requirement is hereby notifying its membership of that fact. The amendments are purely technical in that they update the name of the "Independent Schools Association" to "Independent Schools Associations of British Columbia", and its acronym from "ISA" to "ISABC"; and the name of the "Society of Christian Schools" to "Society of Christian Schools in British Columbia", and its acronym from "SCS" to "SCSBC". These amendments will be presented at the FISA Annual General Meeting on December 8, 2010, to be held in Burnaby, BC. Consult bylaws 2.3, 2.5, 2.6 and 2.8.



GOVERNMENT AND INSTITUTIONAL NEWS

MINISTRY OF EDUCATION

The FISA has been very supportive of the government's policy of offering full-day kindergarten for all schools and parents that wished to avail themselves of the full-day service.

However, it has consistently followed its long-standing policy of promoting and protecting parental rights by maximizing the educational options available to them. In that spirit the FISA had approached government with the request to maintain the option of funded half-day kindergarten for those parents and schools which chose to have the half-day option when full implementation of full-day kindergarten comes into effect in Sept. 2011. The Ministry of Education has granted that request as confirmed by a letter to the FISA, dated August 25, 2010.


The FISA is very pleased the government has recognized parental choice in this matter and suggests a note of thanks to the Minister of Education would be most appropriate.
