# Independent School Staffing

Indicators suggest that independent schools may experience challenges again this year in filling open positions. We remind schools that if you plan to hire a new teacher who is not BC certified it is imperative that you work with the selected teacher in submitting an application to the Teacher Regulation Branch (TRB) promptly. To meet the demand for certification the TRB has recently undertaken restructuring measures including the hiring of more evaluators and streamlining their website, but the certification process depends on applications being complete with all supporting documents

Letters of Permission (LOP) remain a viable alternative if a school is unsuccessful in recruiting a certified teacher. Current LOPs can be extended for the duration of the upcoming school year as long as the extension application is received by July 15, 2019. LOP extensions will only be considered for the same individual, in the same school, for the same position and schools must provide evidence they have advertised the position for at least two weeks. New applications for LOPs are also being accepted.

# Make a Future

FISA thanks the BC Public School Employers' Association (BCPSEA) for the warm welcome they have extended to independent schools that have joined Make a Future. Over 150 independent schools are currently using Make a Future for assistance in the recruiting and hiring of qualified staff leading to a number of successful job placements. Having independent school employers situated side-by-side with public school employers reinforces the importance of having choice in education, both for families to choose the education that their child receives and for educators and support personnel to choose employment that matches their personal beliefs and values. # Professional Standards for BC Educators

The BC Teachers' Council has recently updated the <u>Professional Standards for BC</u> <u>Educators</u>.

These *Standards* apply to all Certificate of Qualifications (COQ) holders regardless of whether a teacher is employed by a public, independent, offshore, or First Nations school. The *Standards* communicate the knowledge, skills, attitudes and values that define educators' work. They serve both as ideals to which educators aspire and expectations that can be reasonably held. FISA encourages COQ holders to review the *Standards* paying special attention to *Standard 9*:

Educators respect and value the history of First Nations, Inuit and Métis in Canada and the impact of the past on the present and the future. Educators contribute towards truth, reconciliation and healing. Educators foster a deeper understanding of ways of knowing and being, histories, and cultures of First Nations, Inuit and Métis. Educators critically examine their own biases, attitudes, beliefs, values and practices to facilitate change. Educators value and respect the languages, heritages, cultures, and ways of knowing and being of First Nations, Inuit and Métis. Educators understand the power of focusing on connectedness and relationship to oneself, family, community and the natural world. Educators integrate First Nations, Inuit and Métis worldviews and perspectives into learning environments.

It is anticipated that the Independent School Teaching Certificate Standards Committee will be making similar modifications to the <u>Independent School Teacher Conduct and Competence Standards</u> for teachers who hold ISTC certification.





# Provincial Outreach Pro-D

FISA's 4th annual Provincial Outreach professional learning series is ready to go. This year's focus is on supporting mental health in schools. The primary presenter will be Dr. Linda O'Neill, Associate Professor UNBC Counselling program. She will guide participants in understanding how trauma-informed practice can enhance social emotional learning (SEL). The videos and resources produced through the Early Action Initiative grant received by FISA will be revealed during the Provincial Outreach. These videos have a panel of experts explaining a variety of SEL approaches and strategies and feature independent school educators demonstrating the methods in action. This Provincial Outreach will be a valuable learning experience for school staff at all levels. FISA is grateful to the Ministry of Education for continuing to support these exceptional learning opportunities and to the many schools who serve as hosts. Registration information will be sent to schools in early September.

## **ERASE** Training

This year FISA offered a record-breaking 10 ERASE training sessions to help ensure that independent

school educators are aware of how to prevent and respond to concerning behaviour, threats, and acts of violence. Nearly 800 independent school educators received training through either a FISA hosted session or a district hosted one. Although the frenzy for training seems to have abated, FISA will continue to work with the Ministry of Education to assess training needs. For 2019/2020 FISA will host the following session:

October 2-3 - Basic VTRA, Aberdeen Hall, Kelowna

November 25-26 – Advanced VTRA, Little Flower Academy, Vancouver

December 2 – Basic DTA, Traditional Learning Academy Online, Langley

Independent school educators are also encouraged to attend ERASE trainings offered through the public school districts. A number of school district training sessions have already been announced for the 2019-2020 school year. These are listed on the FISA website under the <u>Pro-D</u> tab.

# Set-BC Tier 1 Services



SET-BC is a Ministry of Education funded provincial resource

program created to assist BC school districts and Group 1 and 2 independent schools build capacity to use technology to support the diverse needs of students. Schools are able to draw upon SET-BC expertise at no charge.

FISA has been informed that the procedure for requesting Tier 1 professional learning services from SET-BC has been revised. A SET-BC catalogue describing the trainings available and a request for service form can be found on the <u>SET-BC website</u>. Please note SET-BC has designated five training periods throughout the school year with application deadlines of Oct. 1, Dec. 1, Feb. 1, Apr. 1, and June 1.

# Safe School Coordinators Meeting

The Ministry of Education announced that the 2019/2020 Safe School Coordinators Meeting will be held in Richmond on Oct. 28-29. This meeting provides attendees with the latest information regarding Ministry initiatives leading to safer school environments. FISA's practice is to allocate the seats reserved for independent schools through the five FISA-member associations. # 2019 School Community Health Conference Videos

A panel of world-class experts was assembled including keynote addresses by Peter Senge, Monique Gray Smith, Mark Greenberg, and Kimberly Schonert-Reichl. Independent schools are encouraged to share these videos widely and to consider incorporating them into staff development trainings.

# **District/Authority Scholarships**

On behalf of the Ministry of Education, FISA oversees the District/Authority Scholarship (DAS) program for students graduating from independent schools. This year 671 applications were received, an increase from the 610 received last year. In total 430 scholarships in the amount of \$1,250 each were awarded. FISA thanks the DAS committee consisting of John Slofstra (chair), Simon Tuffin, Chris Blesch, Anita Irani and Julie Lade for once again doing a superb job of managing this intensive award process. FISA also expresses appreciation to the army of adjudicators who exercise professional judgment in evaluating the merit of each application. Special thanks go to Helen Bulthuis, Credo Christian School, for managing the paperwork. This will be John Slofstra's last year on the DAS committee. Thank you John for twenty years of committee service, FISA joins the thousands of award winners in expressing our gratitude.

# ARTSTARTS

The BC Arts Council and Province of BC is once again bringing the arts and children together. Through ArtStarts in Schools,

FISA has been allocated nearly \$25,000 to distribute to independent schools who apply for the Artist in Education (AIE) grant for the 2019-2020 school year. Group 1, 2, 3 and 4 independent schools may apply for an AIE grant to support professional artists offering in-school performances in the areas of theatre, music, visual arts, literary arts, and dance. Applications are due Friday, Sept. 13, 2019. AIE grant applications available on the FISA website under the *Services tab*.

#### **Capstone Pro-D Resources**



As part of the BC Ministry of Education graduation requirements, all grade 12 graduates in BC will participate in a Capstone Project beginning in the 2019/2020 school year. The Capstone Project has two main components:

1) A reflection on the students' education journeys which includes looking back at their community, mentors, friendships and learning;

2) A look ahead to their future career and education paths

#### **KPU Dual Credit Program**



A video recording of the KPU Dual Credit Program Information Session held by the AMS of FISABC is available for viewing on the FISA website under the <u>Pro-D tab</u>. The Ministry of Education has verified that independent schools are able to claim funding for students enrolled in dual credit programs with the stipulation that the maximum funding limit of 1.0 FTE (eight courses) applies. Independent schools may charge parents for dual credit tuition costs that exceed Ministry funding. # **FISA Membership Fees**



The membership fees for FISA will remain at \$6.25/FTE for the 2019-2020 school year. Through its five FISA member associations: Association of Christian Schools International (ACSIBC), Associate Member Society of FISABC (AMS), Catholic Independent Schools in BC (CISBC), Independent School Association of BC (ISABC), and Society of Christian Schools in BC (SCSBC) – FISA represents 316 independent schools educating 83,309 students or 13.1% of all K-12 students in BC. FISA has an exemplary record of accomplishment and works hard to ensure that independent schools continue to receive due recognition and funding. We are proud to serve you.

Please note that association membership fees are separate from the FISA fees.

# Fees Collected by FISA





To assist independent schools in accessing services provided by Make a Future and My Education BC iGroup Help Desk (MyEdBC) FISA collects the fees on their behalf. Independent schools using these services will pay the following fees for the 2019/2020 school year:

- ⇒ Make a Future \$3.75/FTE student (plus GST) Total = \$3.94 broken down as \$3.75+.019 GST
- $\Rightarrow$  My Education BC iGroup Help Desk :

\$5.45/FTE student for FISA member schools (plus GST); Total = \$5.72 / \$5.45 +.27 GST
