## **Independent School Child Care Sector Scan - April 2023 Clubs and Activities**

Sometimes schools offer before or after school clubs and activities for children between the ages of 5-12 which do not require a child care license but may "fill the gap" for parents seeking supervision of their child beyond the regular school hours.

Additionally, schools sometimes arrange clubs and activities specifically for youth ages 12-19 who are neurodiverse and for whom the parents seek before or after school supervision

Types of activities that likely **may assist** parents with child minding needs

- Winter/Spring Break camps

- A series of after school "special interest clubs" held on a regular basis for a term or longer

Types of activities that likely do **not assist** parents with child minding needs

- Competitive sport teams (all ages)
- Competitive arts programs (all ages)
- "One off" and short-term activities that are not held on a regular basis

Although the school's goal for providing after-school activities may not be primarily the provision of child care, these activities may form part of a provincial child care strategy, and thus it is important from a Ministry lens to gather data on them.

These types of school sponsored clubs and activities do not require a child care license even if they serve a quasi-child care function. If the data suggests that parents are using school clubs and activities to fill gaps in child care services, FISA may choose to advocate for funding to support such programs.

## Independent School Child Care Sector Scan - April 2023 Expanding FISA's Mandate

If the FISA Board decides to expand its mandate to include advocating on behalf of child care centres affiliated with independent schools the fees would likely be calculated on a cost recovery basis.

Data provided through this survey will provide data as to the number of children (FTE) in affiliated child care facilities and will inform decisions as to additional staffing required in the FISA office if our mandate is expanded.

Example scenarios:

- 5,000 children (FTE) in licensed child care programs @ a fee of \$6.25 = \$31,250
- 10,000 children (FTE) in licensed child care programs @ a fee of \$6.25 = \$62,500
- 5,000 children (FTE) in licensed child care programs @ a fee of \$10.00 = \$50,000
- 10,000 children (FTE) in licensed child care programs @ a fee of \$10.00 = \$100,00
- 5,000 children (FTE) in licensed child care programs @ a fee of \$5.00 = \$25,000
