Good News for Independent Schools!

On Thursday, May 28, 2015 proposed amendments to *The Community Charter* and the *Taxation (Rural Area) Act* were introduced for first reading in the BC legislature by Minister of Finance Michael de Jong.

The new provisions ensure that independent schools will receive statutory exemption from property taxes on all land that is reasonably necessary for school purposes. This includes playgrounds, playing fields, athletic facilities, walkways and parking lots.

While independent schools have received property tax exemptions since 1957, the previous wording was interpreted to refer only to the land upon which the school buildings stood. This allowed municipalities to elect whether to exempt the additional activity-oriented property required to provide an educational program.

The proposed wording of Section 220(1)(l) is as follows:

(l) a building owned by an incorporated institution of learning that is regularly giving children instruction accepted as equivalent to that given in a public school, and that is actually occupied and wholly in use by the incorporated institution for the purpose of giving the instruction, together with

- (i) the land on which the building stands, and
- (ii) an area of the land surrounding the land referred to in subparagraph (i) or improvements on the area of land, or both, that are owned by the incorporated institution and that are reasonably necessary for the purposes of the incorporated institution, including, without limiting this, the following areas of land and improvements:
 - (A) Playing fields, athletic grounds and facilities, playgrounds and improvements related to any of them;
 - (B) Storage, maintenance and administrative facilities;
 - (C) Dormitories for students;
 - (D) Parking lots, walkways and roads; .

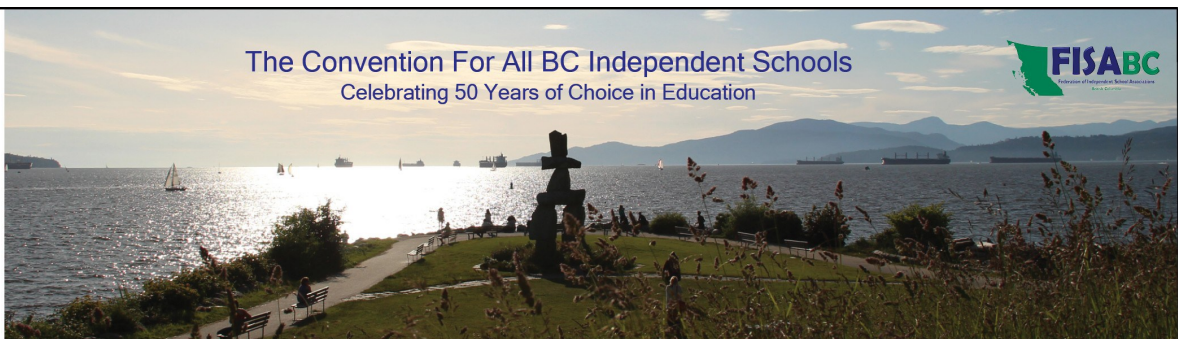
The Vancouver Charter already contains mandatory exemption for association school properties, and will not be amended.

Second reading will occur at a future sitting of the legislature, expected in the Fall. FISA BC is extremely grateful to the government for making these changes to secure historically provided property tax exemptions for all independent schools in the province that offer an educational program equivalent to the public sector.

With a united voice, FISA BC advocates for parental choice, recognition and funding; supports independent school associations in their pursuit of excellence; strengthens educational practice and contributes to the public good.

K-12 Innovation Strategy

Independent schools are encouraged to submit proposals for innovation strategies they would like to implement in September 2015

Independent schools are encouraged to participate in the K-12 Innovation Strategy announced by the Minister of Education on January 29, 2015. An email sent to all independent schools on June 2nd, 2015 asks schools to provide an inventory of learning innovations that impact student learning through curriculum innovations, changes in how the learning environment is organized (scheduling) or changes in the use of space (building design). The Innovation Partnership Working Group (IPWG) is collecting exemplars from public and independent schools that show innovations are making a difference in student learning.

Independent schools are also encouraged to submit proposals on innovation strategies that they would like to implement, beginning in September 2015. The first group of proposals will be accepted until June 17th, and a second group will be accepted in October. Proposals will be reviewed and approved on an ongoing basis as schools identify innovation strategies that enhance student learning.

FISA BC is very pleased to confirm that the Office of the Inspector of Independent Schools will be providing independent schools that are engaged in learning innovation strategies with greater flexibility during school evaluations and monitoring visits. The February 10th, 2015 eboard posting reads as follows:

The Office of the Inspector wants to provide independent schools with the same opportunities as the public system to start exploring the newly designed curriculum in the 2015/16 school year. In order to provide these opportunities, the Office of the Inspector will create greater flexibility in how schools demonstrate curricular compliance.

Schools that plan to explore elements of the newly designed curriculum in 2015/16 will be enabled to take ownership of the course overview framework and are encouraged to develop a model best suited to the school for demonstrating curricular compliance. The Ministry inspection and monitoring process will be adjusted accordingly and the expectation will be that schools exploring the 'new' curriculum will develop a way to explain how the new curriculum is being implemented to ensure that its objectives are being met. Inspection teams will look to school administrators to provide examples of how the school is developing a curricular accountability framework.

FISA BC fees remain at \$5.25 per pupil, while provincial funding rates for adults, special education, and DL increase slightly

FISA BC Fees Remain Unchanged

The FISA BC Board of Directors has approved a budget for 2015-2016 that maintains the membership fee structure at \$5.25/FTE for the coming year.

Increased costs have been offset by increased enrolment in independent schools, enabling a stable fee structure for the coming year. We thank our member schools for their continued support of FISA BC.

Provincial Funding Rates Increase for 2015-2016

While the preliminary estimates for the per student funding for next year is estimating a small increase in some districts and a small decline in others, the targeted funding for independent schools has been increased in all sectors:

Changes in SET-BC Service Delivery for Independent Schools

SET-BC is initiating a new plan for delivering technology support services to schools. The previous delivery model provided almost exclusively individual technology solutions, and individual team training and implementation support. The new model will provide services across three tiers:

- ◆ Tier 1: System-wide Professional Development Services
- ◆ Tier 2: Technology Specific and Classroom-based Solutions
- ◆ Tier 3: Individual Student Solutions

The new service will begin in September. **Please note there is only ONE application deadline this year, on September 18, 2015.** School authorities are encouraged to become familiar with the new service delivery model to determine the best support available for qualifying students.

Each FISA BC member school should have received by email four documents concerning the new service model:

- ◆ Tier Diagram entitled "Service Delivery,"
- ◆ Document describing the services available entitled "SET-BC Services for Independent Schools,"

- ◆ Tier 2: Description and application form for Tier 2 entitled "SET-BC Classroom Based Projects,"
- ◆ Tier 3: "Independent Schools Screening Checklist" to be filled out for each student applying for Tier 3 services.

All four of these documents are also posted on the FISA BC website under "Services" – "Forms/Applications."

School authorities interested in any level of SET-BC service are requested to review the Tier 1 presentation at <http://connect.setbc.org/setservices2>; the Tier 2 presentation at <http://connect.setbc.org/setservices3>; and the Tier 3 presentation at <http://connect.setbc.org/setservices4>; and follow the procedures for application.

ALL applications for SET-BC services must be submitted by mail or courier to FISA BC, 4885 Saint John Paul II Way, Vancouver, BC V5Z 0G3, as SET-BC requires original signatures. They must arrive by **September 18, 2015** in order to be considered. Approved applicants will be informed by the end of October 2015.

ERASE Bullying Training Sessions for Independent Schools

Our thanks to the MoE for funding two ERASE Bullying training sessions for independent schools. Level 1 training was provided at Pacific Academy on May 12, and Level 2 Training was provided at Notre Dame Regional Secondary School on May 20-21, 2015. We also extend our appreciation to Pacific Academy and Notre Dame for hosting these events on behalf of

independent schools.

To date, 247 independent school staff have participated in Level 1 training and 60 in Level 2 training. These 307 people represent 118 schools. Schools that have not yet participated in an ERASE Bullying training session are highly encouraged to do so.

Professional Boundaries Workshop

The TRB is holding a professional identity and boundaries workshop for BC certificate holders this summer. 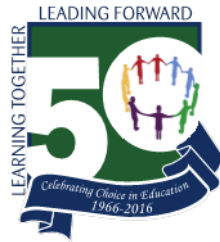
Special Education Focus Groups

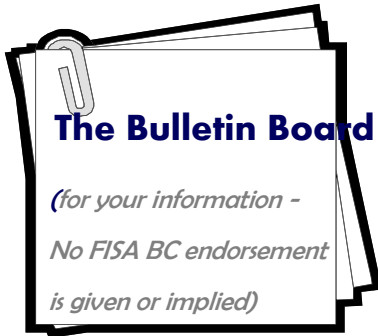


Two directors retire from the FISA BC Board of Directors
